Because of our staff's willingness to do whatever it would take to get started with e-learning right away on March 17th, I feel that we are definitely ahead of the curve and very well-positioned to transition as smoothly as possible into this next phase. I do not think that too much will change for us in Wilmington as we continue moving forward with e-learning, at least in the near future. Participation is no mandatory and required for all schools and all students. There may be some small adjustments and updates to our e-Learning procedures related to the grading & assessment of student work, designated timeframes for students & parents to communicate with teachers / administrators, etc. But overall, I do not expect too many significant changes for Wilmington students and staff as a result of this most recent action from the governor and state board of education.

Food to cover 5 days worth of the school closure will be provided to these students at that time. We will not be able to offer any delivery of meals at this time. Updates regarding the availability of meals for students will be provided on a weekly basis until we return to regular school activities.

You may already be aware that Governor Pritzker signed an executive order on Friday which will officially adjust the 'act of God' status on all regular school days which will be missed as a result of the state-wide required school closure. As we move beyond Monday, March 30th, all Illinois school districts will be required to engage with students on each school day with e-learning / remote learning activities. This will be applicable beginning March 31 up until the current closure date of April 8 and beyond, if another closure extension is decided upon.

The result of this order is a required shift to remote learning for everyone. In Wilmington, the regular face to face school days which were missed during the week before Spring Break (March 17-20) and again tomorrow (March 30) were not legally required to be handled with e-learning. However, our staff worked extremely hard to make that opportunity available immediately for our students, and a tremendous amount of support and appreciation was received from our Wilmington students, parents, and families.

With this most recent executive order from Governor Pritzker, all Illinois public schools will now still be required to complete a full regular school calendar to finish out this year, including a total of 176 pupil participation days, either through e-learning or in-person if the stay at home order is released at any point between April 8th and the end of the school year. Please be aware that the days missed during the week before Spring Break which were labeled with an Act of God designation will count towards that total of 176 days. Those days will NOT need to be made up at the end of the school year.

In moving forward, I am very confident with where we are at today. Because of our staff's willingness to do whatever it would take to get started with e-learning right away on March 17th, I feel that we are definitely ahead of the curve and very well-positioned to transition as smoothly as possible into this next phase. I do not think that too much will change for us in Wilmington as we continue moving forward with e-learning, at least in the near future.

Please be aware that participation in e-learning / remote learning is no longer optional or voluntary. It is a requirement for all Illinois schools and all students. Of course, if your child or children are unable to participate at any time in the weeks ahead due to illness or other extreme family trauma as a result of the coronavirus pandemic, I would ask for you to communicate directly with their teachers and building principal. In the days ahead, we will also be asking our staff to connect directly with all of our families to

We will be committed to ensuring that all students have access to the necessary learning materials in the days and weeks ahead.

Along with this new requirement for participation in e-learning / remote learning, we did receive additional guidelines and recommendations from the state board of education regarding issues such as the grading & assessment of student work, approximate daily time commitment expectations for students & staff, access for students/families who do not have any internet access at home, and much more. In order to make this transition go as smoothly as possible for all Illinois schools, the Governor did allow for school districts to dedicate some time for teachers and administrators to effectively communicate and plan together for a successful shift to our new temporary 'normal' with e-learning. We have decided to devote two days during this upcoming school week - Tuesday March 31 and Wednesday April 1 - for this purpose of planning & communicating together.
